

## **Natural Resource Stewardship Career Pathways Grants**

By working with partners across California, we can help strengthen our state park's systems to ensure that parks are stewarded for generations to come. To meet the pressing challenges faced by our landscapes, we need more trained stewards, at all professional levels across the state to implement climate-resilient solutions. To grow and strengthen our workforce, we seek to increase access and broaden career pathways to reflect the rich diversity of California's growing population. Bringing diverse perspectives, lived experiences, and Indigenous knowledge into landscape stewardship builds strength to the treasured places we share.

Through this grant program, we seek to support and learn from natural resources training and career development programs across the state that also share our commitment to create opportunities for all in the environmental stewardship field.

#### **ELIGIBILITY CRITERIA:**

Do you seek to broaden access, mentorship, and training to communities that have been traditionally underrepresented in the natural resource field? Does your org provide practical professional experience and job training skills that lead to meaningful careers in natural resources? That offer exposure to the types of impactful jobs that support environmental stewardship of our California State Parks? You may be eligible for our *Natural Resource Stewardship Career Pathways* Grants program.

#### For this first round of funding, we are seeking proposals that address the following criteria:

- Provide job training skills, mentorship, and/or career exposure in the natural resources field
- Recruit from traditionally underrepresented communities
- Currently collaborate with California State Parks for natural resources training/workforce development program implementation
- Have active 2021 summer or fall program offering
- Show interest in participating in peer-exchange with other grantees and Parks California to share best practices and identify key barriers and opportunities for strengthening and building more pathways to natural resource careers in parks. Commitment includes participating in two 90-minute workshops in summer and fall 2021.
- Preference will be given to proposals that are also actively participating in regional landscape stewardship collaboratives or networks

Under this grant cycle, Parks California anticipates grant awards will average \$20,000, with a maximum award amount of \$30,000. Applicants should apply for projects that start May 1, 2021 with an intention of completion by January 31, 2022. Groups that are engaged in tribal partnerships are encouraged to apply.

#### 1. Who is eligible to apply for this grant?

Nonprofits\*, tribes, local government (counties, special districts, etc.) that meet the following criteria:

- Provide job training skills, mentorship, and/or career exposure in the natural resources field
- Provide programming for participants from traditionally underrepresented communities
- Have an existing partnership with California State Parks for natural resources training/workforce development program implementation
- Have an active 2021 summer or fall program offering
- Show interest in participating in a peer-exchange with other grantees and Parks
   California to share best practices and identify key barriers and opportunities for natural
   resources workforce development. Commitment includes participating in two 90-minute
   workshops in summer and fall 2021.
- \*Eligibility of nonprofit organizations must exist under the provisions of Section 501c3 of the International Revenue Code.
- 2. Does the program have to take place within California State Parks and State Beaches, or can my program also include job training and workforce development opportunities outside of California State Parks?
  - For this initial round of funding, the grants only support projects that work directly in collaboration with California State Parks. Not all program activities need occur within California State Parks, but California State Parks must be a key partner to the program. Through this pilot program, Parks California seeks to both support and learn from existing collaborations with California State Parks, with a long-term goal to support new and emerging collaborations in the future.
- 3. What kind of program activities are permitted under this grant? Both program operation costs (admin, personnel, stipends, equipment, supplies, PPE, travel, meals, participant housing, etc) and program development costs (not limited to curriculum and training module development, evaluation, certifications, and partnership trainings) that support natural resource stewardship workforce development activities are permitted under this grant. "Natural resource stewardship" may include skills development and experience in areas such as: resource inventory and monitoring, environmental assessments and planning, scientific research, integrating traditional ecological knowledge into stewardship projects, land management and restoration activities, and reporting. While we value the critical role that environmental education programs play in growing the next generation of park stewards, environmental education programs are not funded under this grant program.

- **4.** What are considered ineligible costs under this grant? Fundraising, grant writing, lobbying, costs outside grant performance period and costs outside the approved grant scope.
- **5. Are indirect expenses allowed in this grant?** Indirect expenses will be considered as part of grant proposals and should be clearly outlined in the budget template and narrative.
- 6. Who is this grant program intended to serve?

  This grant program is intended to provide career exposure, job training, and workforce development opportunities to serve communities who have been historically underrepresented in the natural resources field.
- 7. What happens if we are still under quarantine or if quarantine measures resurface later in the year due to COVID-19 impacts? Our goal with Natural Resource Stewardship Career Pathways programs is to financially support programs that create vital connections between people and natural resources job training opportunities. We also understand that our world is facing unprecedented and unpredictable challenges due to COVID-19. It is our hope that the recipients of our grants will use these funds in the way we intended for their programs that they have designed. We will remain flexible to assess the situation when we are closer to the project start dates. We will collaborate with our grant awardees to adapt the project parameters to meet our collective goals within the scope of what is available to communities at that time aligned with state and national public health guidelines.
- **8. How much are the grant awards?** Under this grant cycle, Parks California anticipates awards will average \$20,000 per grantee. Parks California will base the size of the awards on project need, scale, and benefits to the community. Grantees will receive awards upfront upon signing the grant agreement. Awards will be capped at \$30,000.
- **9. Is this a one-year grant?** Grant awards will be for 9-months. Grant funds must be spent within the grant period.
- **10. What are the reporting requirements?** A final narrative and financial report on the use of the funds are required to be submitted. Final report within 30 days upon conclusion of the funded activity. Grantees shall use the report template provided by Parks California.
- 11. In addition to grant reporting, what else will grantees be asked to provide? Parks California wants to illuminate the great work happening across the state. As funders, we will ask grantees to share information such as photos, quotes, interviews, etc. to highlight the collective impact on parks. These stories will be used for internal and external communications and marketing materials. As a part of the program, we will host a welcome call for grantees to make introductions, and then convene two 90-minute workshops through the grant period. Through this program, we also seek to capture case studies, exchange best practices, and identify statewide opportunities for accelerating and broadening access for a more diverse natural resources workforce at all levels.
